Sub. - Action Taken Report on Banning of Pan Masala & Gutkha

In connection with the order passed by the Hon'ble Supreme Court of India dated 23.09.2016 in Transfer Case (Civil) No. 1 of 2010 regarding ban on manufacturing and sale of Gutkha & Pan Masala with Tobacco and /or Nicotine the following actions have been taken .

1. In terms of Regulation No 2.3.4 of the Food Safety and Standards (Prohibition and Restriction on Sales) Regulations, 2011, the Department of Health and Family Welfare, Govt of WB has published a Notification dated 25.10.2016, in the official gazette, prohibiting any manufacture, storage, sale or distribution of 'gutkha', and 'panmasala' containing tobacco and/or nicotine as ingredients, by whatsoever name it is available in the market, prohibited for a period of one year from the date of issue of the notification. A photocopy of the Notification published by the Department of Health and Family Welfare, Govt of West Bengal bearing notification No. 127/HF/CFS/1M-6/2012(Pt) dated 25.10.2016 is annexed herewith.

2. Enforcement machinery has been activated to implement the directive of the notification and to keep strict vigil on this matter. Steps have been taken to alert Municipalities and Municipal Corporations to suitably publicise the order and also to keep strict vigil so that the above mentioned prohibited articles are not available and / or traded in the market. Food Safety Officers and Designated Officers under the FSSAI have been instructed to draw samples and initiate appropriate legal action in case of violations, as per provisions under the

Act.

In addition to the above steps, the National Tobacco Control Programme (NTCP) is now being implemented in the districts of the State of West Bengal. The programme aims at awareness generation amongst the population and in school children regarding the adverse effects of smoking & consumption of tobacco based products. A State Level Co-ordination Committee has been formed for supervision of implementation of the National Tobacco Control Programme (NTCP) in the State with the Chief Secretary as the Chairperson. Similarly District Level & Block Level Coordination Committees have been formed. Further, District level Monitoring Committees were set-up for monitoring the implementation of the Cigarette & Other Tobacco Products Act District Level Enforcement Squads and Block Level Enforcement Squads have also been formed for effective implementation of the various provisions under the COTPA, 2003. Enforcement of COTPA rules regarding new pictorial warnings for Tobacco Products have been communicated to the District Magistrates to ensure that the provision of the aforesaid rules are duly enforced in the districts.

As per the directives of the Hon'ble Supreme Court of India an affidavit affirmed by the Additional Chief Secretary of the Dept. of Health & Family Welfare, Govt. of West Bengal has been filed before the Hon'ble Supreme Court of India on this issue.



I, shri Sudhir Mahajan, IAS, aged S. years, residing at Altinho, Panaji Goa and working as the Commissioner & Secretary (Health), Government of Goa, Secretariat, Porvorim – Goa do hereby solemnly affirm and declare as under:

1. That I am the Commissioner & Secretary (Health) at the Government of Goa and well conversant with the subject matter over the enforcement and implementation of the ban / prohibition over the manufacture is sale of Gutka in the State of Goa and am competent to file the subject affidavit. I have gone through the contents of the orders dated 23.09.2016 passer by the Hon'ble Supreme Court of India in the above Special Leave to Appeal (Civil), where Hon'ble Court has directed Secretaries of Health Departments of all remaining 23 States to file their affidavits within 4 weeks of the aforesaid order dated 23.09.2016 and in pursuance thereof?

- I state that pursuant to the Order dated 03.04.2013 passed by this Hornfale Court, the State of Goa through its then Principal Secretary (Health), stari Panimal Rai, IAS had filed an Affidavit dated 03.06.2013 before this Hon ble Court Annexed hereto and marked as Annexure A is copy of Affidavit dated 03.04.2013 for convenience purposes.
- 3. I state that vide order dated 23.09.2016, this Hon'ble Court passed he following directions which are reproduced herein below for reactive reference:

"At this stage, tearned Amicus Curiae has invited the attention of the Court to the Order dated 3.4.2013 passed by this Court. The relevant part of the said order reads as follows:

"Ms. India Jaising, learned Additional Solicitor General invite Court's attention to notifications issued by the Government States and the Administrators of 5 Union Territories for complete ban on Gutkha and Pan Masala with tobacco nicotine and then stated that notwithstanding the manufacturers have devised a subterfuge for selling Gutkha Masala in separate pouches and in this manner the ban flouted Ms Indira Jaising also placed before the Court xeros of D.O. No P.16012/12/11-Part I dated 27.08.2012 sent by Special Secretary, Ministry of Health and Family Government of India to the Chief Secretaries of all the States the States of Madhya Pradesh, Kerala, Bihar Maharashira, Haryana, Chhatisgarh and Jharkhand and sub that the Court may call upon the remaining States an Territories to issue necessary notifications. In view of the s

(In

made by the learned Additional Solicitor General, we order issue of notice to the Chief Secretaries of the States and the Administrators of the Union Territories which have so far not issued notification in terms of 2006 Act to apprise this court with the reasons as to will they have not taken action pursuant to letter dated 27.08.2012. We also direct the Secretaries, Health Department of all the 23 States and 5 Union Territories to file their affidavits within four veels at the issue of total compliance of the ban imposed on manufacturing and sale of Gutkha and Pan Masala with tobacco and/or nicotine.

Learned Amicus Curiae has also invited our attention to paragraph 21 of the Written Submissions on behalf of the Ministry of Health and Familia Welfare, Government of India, in S.L.P. (C) No. 16308 of 2007 which reads as follows:

"21. It is most respectfully submitted that to circumvent the ban on the sale of gutkha, the manufacturers are selling part massive (without tobacco) with flavoured chewing tobacco in separate sachets but often conjoint and sold together by the same wendors from the same premises, so that consumers can buy the part massive and flavoured chewing tobacco and mix them both and consume the same. Hence, instead of the earlier "ready to consume initials," chewing tobacco companies are selling gutkha in twin packs to be mixed as one"

Learned Amiciis Curiae has also pointed out that this Court has not granted any stay of Regulation 2.3.4 of the Food Safety and Standards (Prohibition & Restrictions on Sales) Regulations, 2011 and the concerned authorities are duty bound to enforce the said regulation framed una Section 92 read with Section 26 of the Food Safety & Standards Act 2006

An

In view of the above, the concerned statutory authorities are directed to comply with the above mandate of law. We also direct the Secretaries Health Department of all the States and Union Territories to file they affidavits before the next date of hearing on the issue of total compliances; the ban imposed on manufacturing and sale of Gutkha and Pan Wasata with tobacco and/or nicotine."

- 4. I state that it is pertinent to note that the State of Goa has enacted the Goa Public Health (Amendment) Act 2005, which Act provides for a complete ban on the manufacture for sale, sell, distribution, storing, stocking for conveying of any food articles containing tobacco or tobacco extracts which is commonly known as Gutka.
- October 2005, State of Goa through its various enforcing agencies sixil as the Food and Drugs Administration, Police etc has been prudeinty and strictly enforcing the ban on the manufacture for sale, sell, distribution, storing, stocking or conveying of any food articles containing to bacco or tobacco extracts which is commonly known as Gutka under the Goa Public Health (Amendment) Act 2005.
- of I state that in essence the Goa Public Health (Amendment) Act 2015 wholly fulfills and complies with the objectives and principles of the Regulation 2:314 of the Food Safety and Standards (Prohibition Restrictions on Sales) Regulations, 2011, in letter and spirit. More so, the banks in the nature of a permanent imposition.

In view of the above submissions I state that there is compliance on behalf of the State of the Goa in so far as enforcement and imposition of bar, on the manufacture for sale, sell, distribution, storing, stocking or conveying of any food articles containing tobacco or tobacco extracts within the State of Goa since October 2005 and therefore there is strict compliance of the directions of this Hon'ble Court

other States across the country under the Food Safety and Standards Act, 2006;

- 3. It is also respectfully submitted that consequent to the above communication, the Special Secretary, Ministry of Health & Family Welfare, Government of India, New Delhi vide undersigned's D O letter no DFDA/PFA(98)/2012 13/Port dated 19.10.2012 was appraised that the State of Goa has already enacted a special legislation named 'Goa Public Health (Amendment) Act, 2005', under which a ban has already been imposed in the State of Goa on the manufacture for sale, sell, distribution, storing, stocking or conveying of any food articles containing tobacco or tobacco extracts (commonly known as 'Gutka') since 2nd October 2005 and that the said amended Act had also come under legal scrutiny challenging its validity before the High Court of Bombay at Panaji Goa bench and the State had successfully sustained the validity of the said legislation and Hombie High Court was pleased to dismiss all such Writ petitions filed against t
- It is further respectfully submitted that the Special Secretary to the Ministry of Health & Family Welfare, Government of India was also informed that consequent to the dismissal of the Writ Petitlon before the Hon'ble High Court, the Petitloners in the said writ petitions had approached the Hon'ble Supreme Court of India through a Special Leave Petition In Appeal (Civil) no. 11818 of 2006 and at Civil Appeal no. 3806 of 2007 and although the Supreme Court had admitted both the Petitions, no specific relief of any nature were granted and the matter is yet to come to be listed for its final hearing before the Hon'ble Supreme Court and hence, the Gutka bantir the State remained in force under the Goa Public Health (Amendment) Act, 2005;

The Hon'ble Supreme Court of India vide interim directions dated 23.9.2016 in the SLP(C) 16308 of 2007 in the matter of Ankur Gutkha Vs Union of India has directed strict enforcement of the Regulation No. 2.3.4 of the Food Safety and Standards(Prohibition and Restriction on Sales)Regulations, 2011 framed under Section 92 r/w Section 26 of the Food Safety and Standards Act, 2006.

Regulation 2.3.4 of FSS (Prohibition and Restriction on Sales) Regulations, 2011 reads as under:

"PRODUCTS NOT TO CONTAIN ANY SUBSTANCES WHICH MAY BE INJURIOUS TO HEALTH: TOBACCO AND NICOTINE SHALL NOT BE USED AS INGREDIENTS IN ANY FOOD PRODUCTS".

Therefore, the manufacture, storage, distribution or sale of GUTKHA/PAN MASALA containing TOBACCO and NICOTINE is prohibited throughout the State under the said provision. Anyone found selling or storing, the banned articles of food shall be liable to a penalty which may extend up to two lakhs rupees.

All Deputy Commissioners, Additional Deputy Commissioners(Independent Charge), District Superintendent of Police, District Medical Officers cum Designated Officers and Food Safety Officers shall ensure compliance of the said order in their respective districts/areas.

This order shall come into force with immediate effect from the date of its notification.

With reference to the above and in response to your email dated 30th Nov 2016, I have the honour to submit herewith the action taken report on the Honourable Supreme Court Order dated 23rd Sept 2016 as follows:

- 1. In compliance to the section 2.3.4 of the Food Safety & Standards (Prohibition & Restriction on Sales) Regulations, 2011, The Commissioner of Food Safety, Meghalaya Shillong has prohibited the manufacture, the storage, transport, the sale or the distribution of Gutkha and Pan Masala containing either tobacco and/or nicotine as an ingredient in the State of Meghalaya with effect from 20th May 2014 vide notification No.CFSM/FSSA/2012/Prohibition/35/2057 dt. 15/5/2014 for a period of one year.
- The prohibition issued vides notification No. CFSM/FSSA/2012/Prohibition/35/2057 dt. 15/5/2014 was extended for another period of 1(one) year with effect from 20/5/2015 vide notification No. CFSM/FSSA/2012/Prohibition/35/83 dated 12th June 2015.
- 3. Considering the health hazard due to consumption of Gutkha & Pan masala containing tobacco and /or nicotine as an ingredient, the manufacture, the storage, transport, the sale or the distribution of Gutkha and Pan Masala containing either tobacco and/or nicotine as an ingredient the prohibition has been extended for a further period of 1(one) year with effect from 20th May 2016 up-to 20th May 2017 vide notification No. CFSM/FSSA/2012/Prohibition/35/150 dated 8th June 2016.

- 4. Regular inspection/checking/raids and monitoring of such products are done/conducted by the teams of Food Safety Officers. Special drive was also conducted by the team of Officers of the Commissionerate of Food Safety with District Administrations and Police to ensure that no such products are sold in the market. This will be conducted in future too
- Further, as per the direction and in compliance to the Honourable Supreme Court order dated 23.09.2016, Affidavit on the action taken on Gutkha & Panmasala containing tobacco/and or nicotine as an ingredient has been filed vide No.Health.286/2016/52 Dated 4th Nov.2016.

With reference to above subject it is submitted that we have received the mail from Assistant Director, (Regulatory Compliance Division) asking about the action taken as per judgment of Hon. Supreme court in Transfer Case (C) 1 of 2010, Dt. 23.09.2016. In this connection we would like to submit that Maharashtra state is enforcing the Regulation 2.3.4 of Food Safety and Standards (Prohibition and Restriction on sales) Regulation 2011 of the Food Safety and Standards Act 2006, in letter and spirit in the State.

All the enforcement authorities in the state of Maharashtra has been instructed to enforce the said order strictly in their respective jurisdiction vide memo dated 8th August 2016, and to enforce the Regulation 2.3.4 of Food Safety and Standards (Prohibition and Restriction on sales) Regulation 2011.

We are continuously implementing said regulation 2.3.4 strictly and for this the state of Maharashtra issued prohibition order form year 2012 every year. From year 2012 until now we have seized such prohibited articles of amount about Rs. 88 cores and launched 3188 prosecutions against who were violating the aforesaid provision.

[As per the direction of Hon. Supreme Court to file the affidavit by the Secretary in the Transfer Case (C) No. 1/2010, the Add. Chief Secretary Medical Education and Drugs Dept. of Govt. of Maharashtra is filing the affidavit and this is already ready and it is notarized and send to Govt. Pleader of the State of Maharashtra in Supreme Court of India for filling. It will be filled shortly.

Further to defend the all litigation which are attached to this Transfer Petition (No.1 of 2010), the request was made to State Government of Maharashtra for appointing the Special Counsel before the Hon.ble Supreme Court. Accordingly the State Govt. Of Maharashtra has engaged the services of Shri Anil Diwan Group I panel Advocate and Smt. Madhavi Diwan Group III panel Advocate.

gutkha and pan masala with tobacco and or nicotine is in place. Any action to circumvent the ban should be dealt firmly and necessary action should be ensured against the culprits. If necessary, assistance of police and excise officials may also be sought in the matter.
